    - Staff Appreciation donations \$2055 collected in e transfer and cash
      - Most of the funds were used. STM received the remaining dollars ~900 to be used for a teacher lunch
      - Staff appreciation expenses were paid by Chair/Vice Chair they were reimbursed for expenses
    - GIC's were opened
    - 1. Non Redeemable not needed until next year, redeemable in July total was \$41,541.96
    - 2. Redeemable GIC, lower interest rate can be redeemed anytime total was \$36,541.95
