## Purdy's Fundraiser Update

Total of 34 orders \$3,720.50. Proceeds from the fundraiser totaled \$976.64. Easy fundraiser, some work on back end to set up, 3 volunteers to sort orders, office staff assisted in distribution to students. Successful and will do again, potential to earn more in future if we can increase participation (school has 500+ students)

#### Casino Update

March 15-16, 2024

Currently 50% volunteer shifts are filled, this is great but the push is on. Will be increasing promotion through emails, texts and social media. Suggestion was put forward to possibly offer shorter shifts – this could work but is a logistical challenge. We can look at this option as we get closer to the due date – and in the mean-time Melissa can inquire about how we could offer the 4 hour vs. 8 hour shifts. For example, it is difficult to split jobs such as cashier because the training is done at the start of the shift, not for the second person coming on for a split shift. Melissa will contact our advisor to see if he has suggestions for filling volunteer shifts. We also discussed use of angels if we have to, Melissa to confirm how much notice they need, how to hire them and how much they cost. We believe it's around \$60 per shift. Casino application paperwork has been submitted and everything is on track.

Discussed the casino sign up website. The pop\_-up adds are distracting at www.signup.com. The group discussed spending \$9.99 for three months (January, February, and March) to eliminate pop\_ups.
