7. New Business

- Basketball Court Grant Application (Cooper)
 - Cumberland assisted with the application process and the school has applied for the grant.
 - Cooper/Cumberland The basketball court project will cost approximately \$138,000-140,000. \$70,000 will be withdrawn from the casino account, and \$70,000 provided through the grant. The council expects to hear back regarding the grant in March 2025, with September implementation. This means the majority of the GIC would be withdrawn.
 - Cumberland \$37,000 is available for withdrawal at any time, with an extra \$5,000 from the casino account.
 - Myskiw Any other spending requirements (music, other programs, jersey's), the school will pay for. With \$15,000 available, Myskiw will ensure the other goals are met.
 - The cost for casino advisers will also need to be considered.
