 - Christmas campaign goal was \$3000. Actual money raised was \$1,822.00, which equaled \$478. 28 in profits.

 - cheque was sent to the wrong Nicole (outdated account information from 2023/24)
 - thinks the campaign didn't run for a long enough period
 - \$782 in pending orders that weren't finalized
 - Easter campaign option
 - Can try an Easter campaign
 - Myskiw in favour of Easter campaign, suggests forgoing Christmas campaigns going forward
 - Cooper upon reflection, the Christmas fundraiser was not time consuming and is not cost prohibitive to run. Perhaps there could be more communication through The Scoop and mini catalogues could be provided. Cooper would like to try it two times a year with adjustments.
 - Boileau supports the Easter campaign
 - Holder has capacity and will find dates
