 - There are six grade 7 and 8 classes
 - There are five grade 9 classes
 - Usually get ~25 new students through the year.
 - Class sizes are currently 30-34 students each.

 - o 55 soccer
 - o 7 ringette
 - o 12-13 baseball
 - Had some challenges with timetables, thank you for your patience
 - All toilets have been fixed with exception of 2 in the boys bathroom
 - 2 new teachers

 - Rico English, Phys Ed, Social
 - School Soccer teams started last week
 - Cross Country will start in the next couple weeks, if you have any children who are runners, please encourage them to join.

 - Majority of students recognize the rule and haven't had too many issues, as it was implemented last year.
